

The High Cost of Sticking with Gravel

You still have a dirt road that turns to soup in March and dust in August.

Contrast this with a properly installed asphalt driveway. Asphalt is a flexible pavement, meaning it can handle the minor shifts of the earth, but it is also a bound material. When a heavy load rolls over it, the weight is distributed evenly across the surface rather than digging into it. There is no displacement. There is no dust. There is no mud. The "rustic charm" of gravel quickly fades when you are power-washing mud off your siding or replacing the suspension components on your car because the washboard road rattled them to pieces. It is time to stop romanticizing infrastructure that doesn't work.
